Recently our contributions back to the Dandenong Ranges area has reached \$5 million! We are extremely proud that this milestone has been reached with recent worthy commitment of funds to groups such as the Upwey Men's Shed (\$80,000) and smaller contributions such as Halloween on the Green (\$2,500) – a great initiative run by the Philanthropic Collective and is becoming a 'must attend' event at the end of October in our local calendar.

The Emerald Hub project is progressing and is an impressive building which will service the wider community. Our \$250,000 contribution to get this project off the ground is another example of how we can invest in our communities and help many people.

With a commitment of \$55,000 the Upwey Tecoma Football Netball Club and Upwey Tecoma Cricket Club will be installing a large electronic scoreboard which will not only benefit the football and cricket clubs that utilise the ground, it will also be a great community asset for fundraising movie nights and the like.


