

#### Grants and donations

In January this year we donated two Vital Signs Monitors to the Angliss Hospital which will be dedicated to paediatric patients. These monitors will be particularly useful for those with respiratory conditions as the units will measure their oxygen saturations continuously and more accurately. Having additional machines will help to ensure machines can be left on one child overnight and sleep is not disturbed which also alleviates the stress for parents.

We are pleased to announce that all staff from our branches in Upwey, Belgrave and Cockatoo were given the opportunity to nominate a local community group to receive a \$1,000 one-off grant. This follows on from the successful initiative in 2018 where

fifteen groups received a surprise call from staff members advising them of the grant.

Normally we would distribute around 9,000 free meals a year. This is done through our sit-down meals at Upwey on a Monday night and Ferntree Gully on a Wednesday night as well as our delivered Community Casseroles meals to locals needing an extra hand in the Dandenong Ranges and surrounds. Since restrictions commenced, the meals that we have distributed have gone from around 200 a week to over 600. We have been so encouraged to have a generous community around us, prepared to pitch in and support others in need at this time."
