# How to complete Your Proxy form

# **1.Appointment of Proxy – General Information**

A shareholder entitled to attend and vote at the meeting may appoint a proxy to attend and vote on their behalf.

## 2.Your name and address

Proxy forms for corporate shareholders should be signed in accordance with your company's constitution or the *Corporations Act.* If a representative of your company is to attend the meeting, the appropriate 'Certificate of Appointment of Corporate Representative' must be produced before admission to the meeting.
