#### **Target Market**

The retail clients for whom this product has been designed are individuals who:

- · want a credit card facility to make purchases and perform other transactions
- want to manage short term cash flow needs by using the credit card facility, including by being able to temporarily defer repayment of debt
- · want a credit card facility with lower purchase interest rate and annual fee
- want a credit card facility limit of \$1,000 or more and can afford to repay the credit card facility

#### **Product Description**

A Bendigo Bright Credit Card is a credit card facility that allows a retail client to make purchases and perform other transactions. A retail client can use their credit card facility and associated card in a variety of ways, including in person at retailers who accept the card, online and over the telephone. Retail clients are required to make at least minimum monthly repayments.
