#### Product

This target market determination (TMD) applies to Bendigo Bank's Non-Individual Residential Investment Principal & Interest Home Loan (Fixed Rate).

## 1. Target market for this product

#### **Target Market**

The retail clients for whom this product has been designed are non-trading companies or trusts (discretionary or family) with a corporate trustee who:

- want a term loan to finance or refinance the acquisition of residential property for the purpose of it being used as a residential investment;
- want to make principal and interest payments over the term of the loan;
- want certainty of a fixed interest rate and fixed repayments for a fixed rate period, with limited ability to make additional repayments without incurring an extra charge;
- · can afford the loan; and
- can provide the residential property as security for the loan.

## **Product Description**

Bendigo Bank's Non-Individual Residential Investment Principal & Interest Home Loan (Fixed Rate) is a term loan (up to a maximum term of 25 years) which is used to finance or refinance the acquisition of a residential investment property. A fixed interest rate applies to the home loan for a fixed period. At the end of the period, the retail client can nominate a new fixed interest rate period, capped at no more than five years and within the remaining term of the loan, otherwise the home loan will convert to a variable rate loan. Retail clients have limited ability to make additional repayments without incurring early repayment costs. Regular principal and interest repayments are required over the term of the loan.

#### Product key attributes

The key attributes of this product that make it likely to be consistent with the target market described above, include:

Term loan	Retail clients that want to repay their loan over medium to long term period (up to a maximum of 25 years).	
Residential Investment	Retail clients who will use the residential property acquired with the loan as a residential investment residence. This product may not be suitable for retail clients who will use the residential property to live in as a principal place of residence.

	Non-trading companies – all directors are to be listed as guarantors of the loan.	
Suitable Entity Type	Family or Discretionary Trusts where there is a corporate trustee – all beneficiaries are natural persons.	
	This product may not be suitable where all parties to the business are individuals, and the business is not a corporate (or company).	
Regular repayments of principal and interest	Retail clients who want to make regular scheduled principal and interest repayments over the term of the loan. Retail clients are able to set up weekly, fortnightly or monthly repayment frequencies.	
Fixed interest rate	A fixed interest rate means the interest rate will remain the same for a nominated period. At the end of the period, the retail client can nominate a new fixed interest rate period, capped at no more than five years and within the remaining term of the loan, otherwise the home loan will convert to a variable rate loan.	
Early repayments and redraw	Retail clients who do not require the flexibility to make additional repayments of the specified cap without incurring an extra fee or charge. Additional repayments during the fixed rate period are capped at 20% of principal amount at the commencement of a fixed rate period. Repayments above this cap, or changes to the fixed rate period (eg ending it early), may incur in additional fees or charges (eg break costs). Retail clients can access additional repayments through the redraw function in internet banking (1 repayment amount is preserved and not accessible).	
Security over residential property	Retail clients that can use the residential property they have acquired with the loan as security for it.

Bendigo Bank applies certain conditions and restrictions to the distribution of this product so that distribution is likely to be to retail clients within the target market for this product. The conditions and restrictions are:
