



# Market Commentary

The quarter ending 30 September 2021 saw the Fund pay 0.37%p.a. being above the quarter's indicative rate of 0.32%p.a. The indicative rate for the December 2021 quarter has been set at 032%p.a. The Reserve Bank of Australia (RBA) held the official cash rate at 0.10% throughout the quarter. The RBA's package of policies including record low interest rates the bond purchase program, the yield target and funding provided under the Term Funding Facility continue to provide substantial and ongoing support to the Australian economy. Whilst the income of the Fund's assets remained relatively stable over the quarter, income generated from the assets of the Fund continues to be impacted by the current portfolio mix being underweight mortgages and overweight lower yielding liquid investments. Mortgage rates remain at record lows and there continues to be strong competition for high credit quality borrowers as the Fund looks to increase weighting to mortgage investments.
