

Sandhurst Strategic Income Fund - Class A units

Monthly fund update - December 2020

Investment approach

The Fund aims to provide customers with regular income and may offer higher returns with a lower level of risk through the market cycle in an effort to outperform a static investment in similar assets by strategically managing its portfolio in varying market and economic conditions.

The objective of the Fund is to outperform its benchmark (after fees) over any two year period.



Portfolio performance

For the month of December 2020, the Strategic Income Fund achieved a 0.05% return for the Class A units. Projecting the monthly return for the next 12 months would provide an annualised return of 0.60% after fees.


December was a positive month for global equities as approved Covid-19 vaccines began to be rolled out. Market sentiment was also supported by hopes of a new US fiscal package and a Brexit trade deal. US markets rallied over the month with the S&P500 (a market capitalisation weighted index of the 500 largest US publicly traded companies) rising 3.7%. Despite European countries being forced into new lockdowns with case numbers rising, the UK FTSE increased 3.1% in December and the German Dax rose 1.0%. In Australia, the ASX200 increased 1.1% on the month.

Following the RBA rate cut in November, short dated government bond yields and Bank Bills drifted lower to find new lows in December.

December was a relatively quiet month for the Australian credit market. Credit spreads, the difference between the yield on credit assets and risk free assets, moved tighter as investors risk appetite continued to improve. As a result, corporates outperformed government bonds during the month.

The Fund's focus remains on high quality investments with minimal volatility. The Fund has 33.7% in cash instruments, 31.2% in Floating Rate Notes (FRN) and 35.1% in highly rated securitised assets. Approximately 72.5% of non-cash assets are rated AA- or higher.
