

# Sandhurst Strategic Income Fund - Class A units

## Monthly fund update - February 2021

### Investment approach

The Fund aims to provide customers with regular income and may offer higher returns with a lower level of risk through the market cycle in an effort to outperform a static investment in similar assets by strategically managing its portfolio in varying market and economic conditions.

The objective of the Fund is to outperform its benchmark (after fees) over any two year period.



Australia Ratings has assigned a SUPERIOR investment rating with a BLUE product complexity indicator designating the Fund as a Relatively Simple Product.<sup>4</sup>

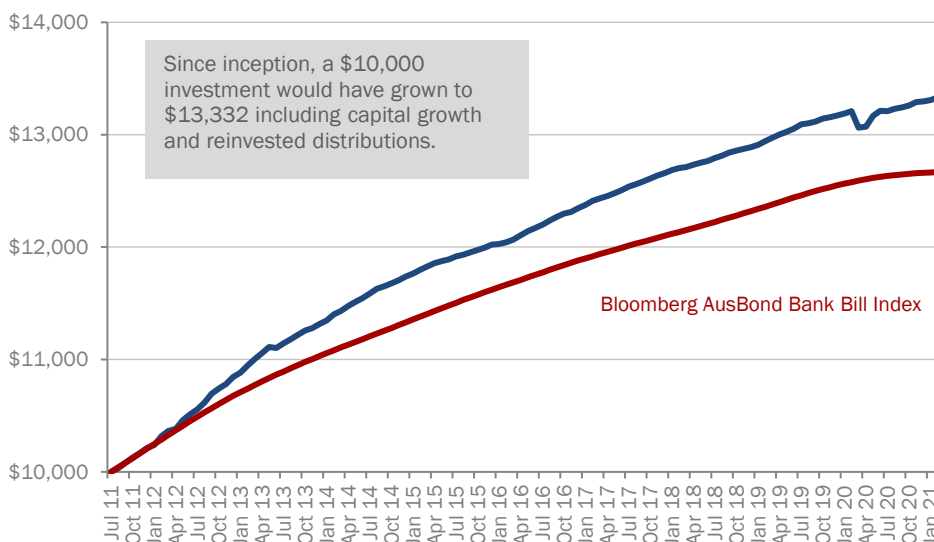

## Portfolio performance

For the month of February 2021, the Strategic Income Fund achieved a 0.18% return for the Class A units. Projecting the monthly return for the next 12 months would provide an annualised return of 2.11% after fees. Returns were supported by another positive month in credit income markets.

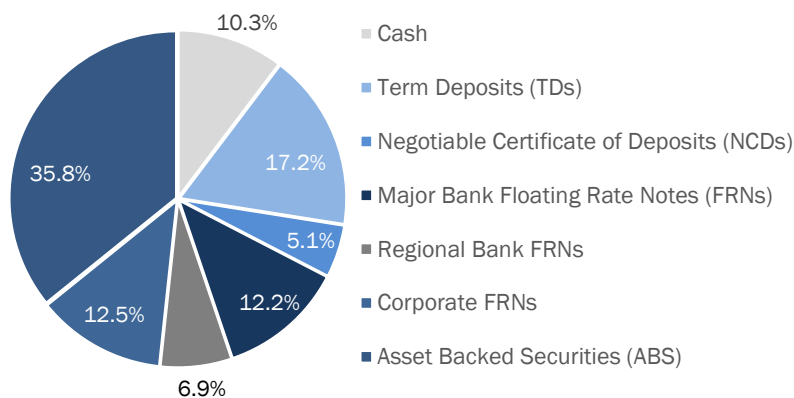
February was a volatile month for global equities as a host of factors appeared to influence markets. Equities began the month strongly on the back of US reporting season and progress towards a new stimulus package. However, the sharp rise in global bond yields later in the month offset some of these gains as investors recalibrated their inflation outlook, prompting concerns that central banks may increase interest rates sooner than expected.

US markets were up over the month with the S&P500 (a market capitalisation weighted index of the 500 largest US publicly traded companies) rising 2.6%. European markets experienced similar gains with the UK FTSE up 1.2% in February and the German Dax gaining 2.6%. In Australia, equities underperformed with the ASX200 posting a modest 1.0% gain over the month.

In credit markets, the difference between the yield on credit assets and risk-free assets (Credit Spread) rallied tighter as investors risk appetite continued to improve. As a result, corporates outperformed government bonds during the month.

The Fund's focus remains on high quality investments with minimal volatility. The Fund has 33% in cash instruments, 31% in Floating Rate Notes (FRN) and 36% in highly rated securitised assets. Approximately 73% of non-cash assets are rated AA- or higher.

3. Morningstar rates managed funds from one to five stars based on how well they've performed (after adjusting for risk) in comparison to similar funds. Within each Morningstar Category, the top 10% of funds receive five stars, the next 22.5% four stars, the middle 35% three stars, the next 22.5% two stars, and the bottom 10% receive one star. Funds are rated for up to three time periods - three, five, and 10 years - and these ratings are combined to produce an overall rating. Funds with less than three years of history are not rated. Ratings are objective, based entirely on a mathematical evaluation of past performance. They're a useful tool for identifying funds worthy of further research, but shouldn't be considered buy or sell recommendations.
