

Sandhurst Strategic Income Fund - Class A units

Monthly fund update - June 2021

Investment approach

The Fund aims to provide customers with regular income and may offer higher returns with a lower level of risk through the market cycle in an effort to outperform a static investment in similar assets by strategically managing its portfolio in varying market and economic conditions.

The objective of the Fund is to outperform its benchmark (after fees) over any two year period.

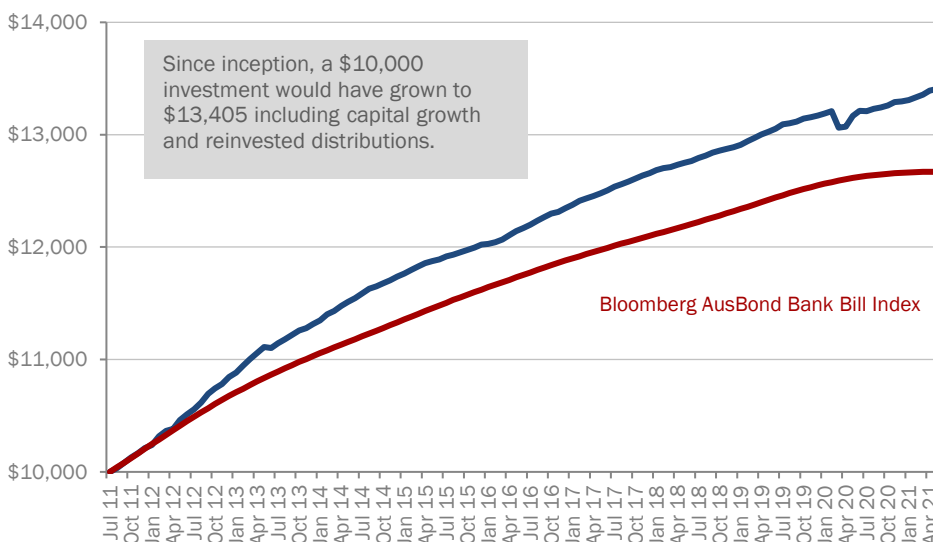

Portfolio performance

For the month of June 2021, the Strategic Income Fund had a -0.01% return for the Class A units. For the June 2021 quarter, the Fund paid out distributions representing a 0.37% return for the quarter making the full year returns 1.46% after fees.

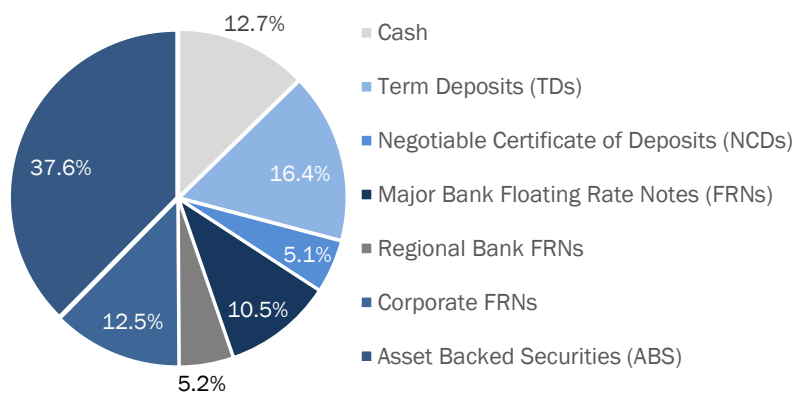
In June, global markets were volatile as positive economic prints conflicted with growing global Covid cases. In the US, investors had to contend with mixed signals from the US Federal Reserve on monetary policy, however the general belief remained the Federal Reserve would not rush to withdraw stimulus. The ongoing fears about higher inflation seemed to subside over the month, as yield curves flattened. While sentiment was also bolstered by the US\$1.2 trillion bipartisan deal between the White House and the US Senate on infrastructure spending.

In Australia, domestic economic data releases were strong, with the labour market in particular continuing to show strength with unemployment dropping to 5.3% in the latest release. The strong labour market and buoyant housing market lifted enthusiasm over the month. However, this optimism was impacted by parts of Australia being locked down to control the ongoing Covid outbreak.

Australian credit market spreads (the difference between the yield on credit assets and risk-free assets) tightened marginally in June, with financials outperforming non financials. It was a reasonably quiet month for Australian financials, noting the RBA's Term Funding Facility closed to new drawdowns on 30 June.

The Fund's focus remains on high quality investments with minimal volatility. The Fund has 34% in cash instruments, 28% in Floating Rate Notes (FRN) and 38% in highly rated, securitised assets. Approximately 72% of non-cash assets are rated AA- or higher.

2. The benchmark for the Fund is Bloomberg AusBond Bank Bill Index.
3. Morningstar rates managed funds from one to five stars based on how well they've performed (after adjusting for risk) in comparison to similar funds. Within each Morningstar Category, the top 10% of funds receive five stars, the next 22.5% four stars, the middle 35% three stars, the next 22.5% two stars, and the bottom 10% receive one star. Funds are rated for up to three time periods - three, five, and 10 years - and these ratings are combined to produce an overall rating. Funds with less than three years of history are not rated. Ratings are objective, based entirely on a mathematical evaluation of past performance. They're a useful tool for identifying funds worthy of further research, but shouldn't be considered buy or sell recommendations.
