

Sandhurst Strategic Income Fund - Class A units

Monthly fund update - September 2020

Investment approach

The Fund aims to provide customers with regular income and may offer higher returns with a lower level of risk through the market cycle in an effort to outperform a static investment in similar assets by strategically managing its portfolio in varying market and economic conditions.

The objective of the Fund is to outperform its benchmark (after fees) over any two year period.

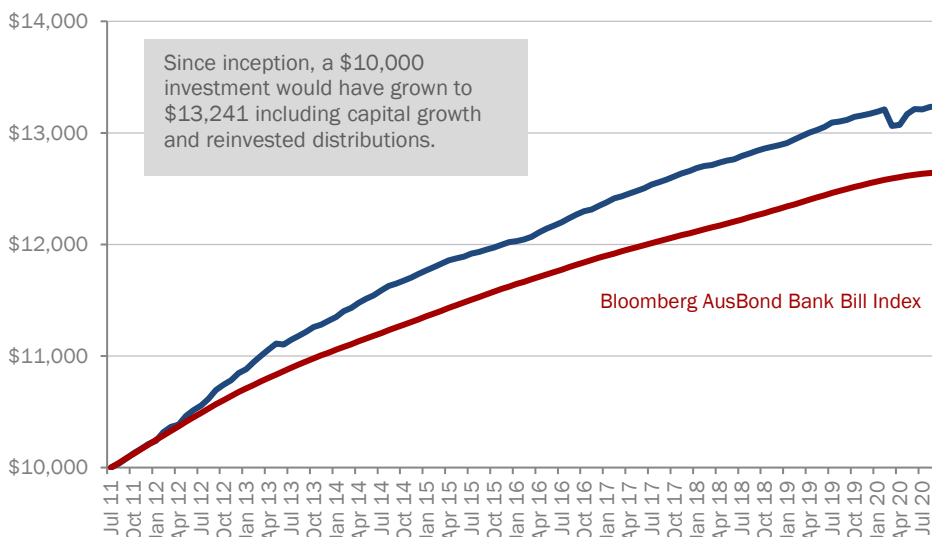

Portfolio performance

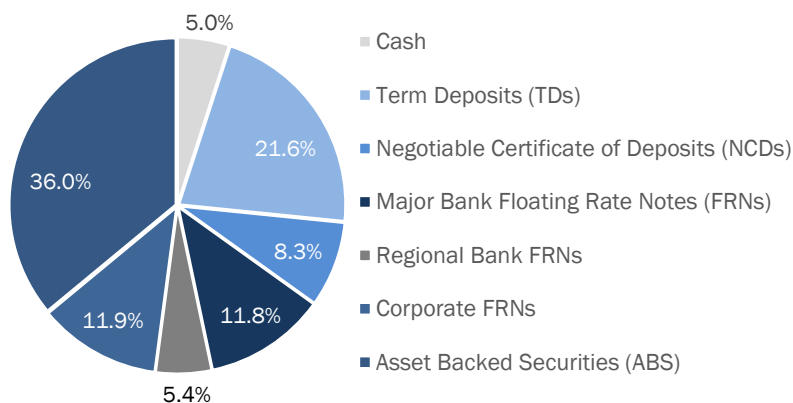
For the month of September 2020, the Strategic Income Fund achieved a 0.08% return for the Class A units. If September's return is projected for the next 12 months, it would be an annualised return of 0.96% after fees. Returns for the month were supported by another positive month in fixed income markets, despite a risk off sentiment dominating equity markets.

September was a volatile month for global equities as a host of factors appeared to influence markets. European countries were forced to reinstate lockdowns to contain a second wave of Covid-19. The German Dax fell 1.4% in September and the UK FTSE dropped 1.6%. US markets were dominated by stimulus negotiations, as the Republicans and Democrats failed to agree on another stimulus package. The S&P500 (a market capitalisation weighted index of the 500 largest US publicly traded companies) posted its first monthly decline since March, falling 3.9%. In Australia, equities gave back August gains, with the ASX200 index falling 3.7%.

The month began with the Reserve Bank of Australia (RBA) announcing an increase and expansion of the Term Funding Facility (TFF). The TFF will continue to provide 3-year fixed rate funding to authorised deposit-taking institutions (ADIs) at 0.25% from 1 October 2020 through to 30 June 2021, for up to 2% of the bank's lending.

The cash rate remained unchanged in September, however a speech by RBA Deputy Governor Debelle on 22 September prompted the market to anticipate another shift lower in rates during 2020. Following the speech, short dated government bond yields and Bank Bills found new lows.

Asset allocation



In credit markets, the spread between the yield on risk free and risk assets (Credit Spread) had reduced since late April, this Credit Spread contraction came to a halt in September. Credit Spreads widened marginally as increased volatility offshore impacted local sentiment. As a result, government bonds outperformed corporates over the month.

The Fund's focus remains on high quality investments with minimal volatility. The Fund has 34.9% in cash instruments, 29.1% in Floating Rate Notes (FRN) and 36.0% in highly rated securitised assets. Approximately 74.7% of non-cash assets are rated AA- or higher.
