Monthly fund update - January 2021

Investment approach

The Fund aims to provide customers with regular income and may offer higher returns with a lower level of risk through the market cycle in an effort to outperform a static investment in similar assets by strategically managing its portfolio in varying market and economic conditions.

The objective of the Fund is to outperform its benchmark (after fees) over any two year period.



Portfolio performance


January saw another constructive month in fixed income markets and equity markets as risk on sentiment dominated. For the month of January 2021, the Strategic Income Fund achieved a 0.11% return for the Class B units (1.27% pa).

January was a volatile month for global equities as a host of factors appeared to influence market. Some key influences on sentiment included: the vaccine rollout, a lift in global virus case numbers, US earnings season, US presidential inauguration, conclusion of the Brexit trade deal and the proposed US stimulus package. US markets were down over the month with the S&P500 falling 1.1%. European markets experienced similar losses with the UK FTSE falling 0.8% in January and the German Dax dropped 2.1%. In Australia, equities outperformed with the ASX200 posting a 0.3% gain over the month.

In credit markets, spreads contracted over the month as investors risk appetite continued to improve. As a result, corporates outperformed government bonds during the month.

The Fund manager remains cautious and focussed on high quality investments that reduce the volatility of the Fund during market events. Approximately 34% of the portfolio is in cash instruments, 31% in bank and corporate Floating Rate Notes and 35% is in highly rated securitised instruments. There are no unrated or subordinated assets in the Fund and approximately 72% of non-cash assets are rated AA- or higher.
