## Bendigo Conservative Index Fund

### Investment Objective

The Fund is managed to achieve a return broadly equivalent to the Consumer Price Index (CPI) plus a margin of 2% (net of fees and taxes) over a full market cycle.

### Investment Strategy

The Fund is a low-cost multi-asset strategy that is positioned such that its Strategic Asset Allocation (SAA) underwrites the majority of returns (90%), with Active Asset Allocation (AAA) and manager selection accounting for the remainder. The Fund's SAA is predominately gained through low-cost index funds, with the exception of AAA positioning which is implemented through futures and ETFs.

### Investor Profile

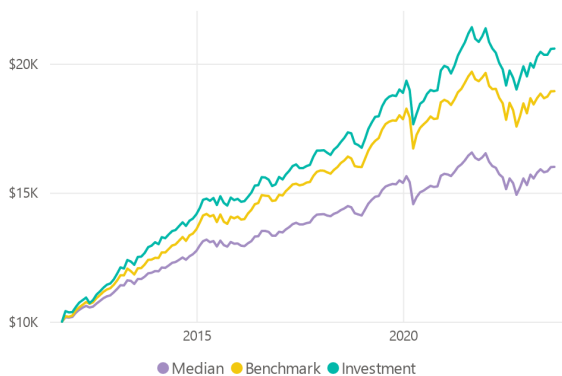
Suitable for investors with a moderate risk tolerance, seeking investment returns that are likely to be more heavily influenced by income. Given the risks inherent in a number of the Fund's targeted asset class exposures, we believe an appropriate investment horizon is three or more years.

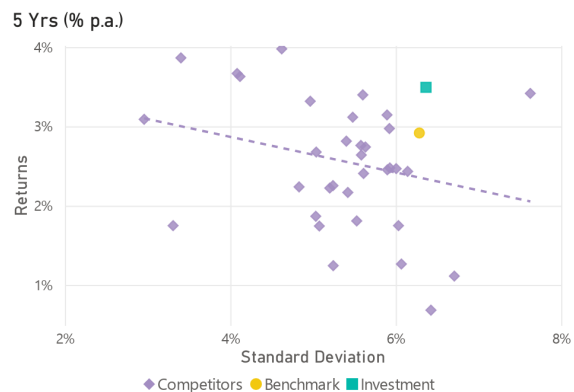
