Our Community Bank branch

Thank you to those shareholders who attended the AGM in November and provided feedback and questions. Your attendance and interest in your local Albany Community Bank Branch is appreciated by the Board and staff.

Many of you made it clear that a dividend is paramount and the Board delivered it's message that it is a priority to ensure this is paid as soon as the Auditor advises the Directors of the company that there are more current assets than current liabilities (both before and after the dividend payment) to pay a dividend.

For some of you, including the current Board and staff, the following overview is provided to remind us of what it meant to buy shares in 2006 and start a Community Bank branch.

Below is the 'shareholders story' for the Albany Community Bank Branch.

The Albany Community Bank Branch (Albany (WA) Community Financial Services Limited) is a public company and like any investment in companies listed on the stock exchange (Community Bank branches use the Low Volume Market as approved by ASIC), the investment carries risks which would have been outlined in the prospectus provided when shares were purchased.

Our Community Bank branch raised \$854,557 in initial capital from local shareholders who were all issued with a legal prospectus and subsequent share certificate.

The business did not reach the projected growth in the initial years; this was due to a number of factors including the Global Financial Crisis, significant staff changes and lack of community support in transferring business to the Community Bank branch for a number of reasons. Due to the above factors the company

exhausted its initial capital and borrowed in excess of \$200,000 from Bendigo and Adelaide Bank which allowed us to continue to operate.

This debt has reduced substantially over the past few years and is all but extinguished with the Board of Directors anticipating a dividend for shareholders in the 2020/21 financial year provided that the company's Auditor approves the recommendation. Our current Board of Directors take their role and the responsibility attached to the governance of the company seriously.

Over the past few years the Board has been restructured and we have seen a number of staff changes which has seen substantial growth in our business.

We have invested via donations and sponsorships into the Albany community since inception and will continue to do so. Bendigo and Adelaide Bank has provided substantial financial support to enable us to provide this community funding. Under our constitution when we make a profit up to 80% of those profits must be spent on community and up to 20% to shareholders in dividends.

Mental health

Is a topic in every home, school, workplace and community. The Board have wanted to deliver in this area and are pleased to announce that a safeTALK workshop for Youth Suicide and an information night on Zero2Hero will be held on 27 February 2020. Zero2Hero will facilitate the safeTALK program and hold an information session in the evening on what they do and opportunities available. Some of you heard our four camp Bendigo ambassadors speak at the AGM and these leaders of tomorrow will be assisting in the planning and preparation of the safeTALK workshop, we are listening to them as they provide the information that our youth are talking about including their needs.
