Acknowledgement and Publications

Acknowledgment of Alice Springs Community Bank ® Bendigo Bank Funding (ASCB)

When do I need to acknowledge ASCB support?

If you receive funding through the ASCB Grants Program, you are required to prominently acknowledge this support in all media releases and promotional activity for funding agreement with the ASCB.

Where do I need to include the acknowledgement?

This can include:

- media releases about the funded activity or issued by a funded organisation
- advertisements to promote the funded activity or issued by a funded organisation
- posters or flyers for your funded activity or issued by a funded organisation
- publications for or about your funded activity or issued by a funded organisation
- banners printed that promote the funded activity or organisation
- websites for your funded activity or organisation
- **newsletters** from funded organisations
- your email signatures for funded organisations

Please note there should be no difference in sending out media releases or e-newsletters via email. Any information you distribute that promotes activities that have received support through the ASCB needs to include an acknowledgment.

Why is this important?

The inclusion of an acknowledgement links the outcomes of funding with the grant. This builds public consciousness of the value and importance of public funding.

How do I use the logo?

The placement of the ASCB logo may vary in size but must always be reproduced in appropriate proportion to the context in which it is being used. To ensure clarity, the logo must always be surrounded by adequate space, clear of text or images.

Acquittals:

All Sponsorships/grants need to be acquitted back to the ASCB within one month of the date of the event.

All acquittals require:

- Financial breakdown of how the funds were spent
- A written report of the event that was held
- 6 x Still photo graphs of the event that can be used on media and marketing
- Copies of all marketing that were used brochures/flyers/print out of Facebook/webpage etc.

All previous sponsorships or grants must be acquitted prior to a new application; otherwise your application may be declined.
