Indoor heated pool update.



During our **Community Bank®** branch's initial development in 2007, the results of a community poll showed, that of 31 identified needs in the community, a heated pool for Apollo Bay gained the most support and was the top priority of survey respondents.

In 2010 the **Community Bank®** company Board identified the construction of a heated indoor pool as a major community project to pursue and contributed to fund the Feasibility Study that was completed in 2011.

The non-profit association, Apollo Bay Aquatic Centre formed in 2011, boasts some 400 members. Its committee has been busy since the last shareholder newsletter in July 2013, lobbying local, State and Federal governments.

Despite being the most marginal seat in the country, unfortunately Apollo Bay did not attract capital funding for this much needed facility at the last Federal election.

It became evident that the project was far more likely to attract funding as part of a larger facility in a more prominent position (such as the Harbour) to provide for the local community and the tourists. The Harbour was always the preferred site as identified by the Feasibility Study.

The Planning Scheme Amendment of the Harbour Master Plan on display earlier this year, deemed an indoor pool facility/health and wellbeing as a prohibited use. Much campaigning followed to change this and a proposal for the inclusion of an indoor pool/ sea baths as part of a Harbour re-development was presented to Council in March. This Recreation and Community Hub proposal was well supported by a wide range of prominent organisations in the Apollo Bay community.

After a concerted community effort, Council confirmed its support at the April Council meeting this year. As minuted, the 'Council confirms it supports provision being made within the Special Use Zone (Schedule 2) for a permit application to be made for an indoor swimming pool/sea baths and other health and wellbeing uses, and that provision be made for the potential for such facilities to be included within any Development Plan prepared for the Harbour precinct under those controls.'

Following a Directions Hearing in May this year, conducted by Planning Panels Victoria, the Council has now made changes to the Planning Scheme Amendment for the Harbour precinct. If adopted, the next step will be ensuring that the pool facility be included in the Development Plan.

Over the last year, the Aquatic Centre committee has also raised a total of \$160,000 in pledges and donations toward the construction of an indoor pool. This is an amazing effort from our small community.
