We would like to examine options expand our presence into Bittern and Crib Point to take advantage of the port growth as it occurs and also continue to maintain and enhance our presence in Flinders extending to the rural area of Red Hill to capture more tourist and local business if that is possible.

In Your Interest ...

Balnarring's Low Volume Market granted



I am thrilled to be able to announce to you that Balnarring & District Community Services Ltd has finally been granted Low Volume Market status with ASIC. This may not mean anything to many of you, but for those of you who want to buy or sell shares in our company, it is fantastic news.

Up until now, trading your shares has been a little time consuming. As Company Secretary, my hands have been tied as to the extent of assistance I have been able to provide you with. I know that for many, there has been much frustration. However, everything is now much more simplified and you can do everything yourself with greater ease. All you need to do is click on "Trading Shares" on the left hand side of our homepage (www.bendigobank.com.au/balnarring) and follow the instructions.

In order to buy or sell shares in Balnarring & District Community Services Limited you must first register your interest formally with me. All shareholders who have already informed me, or past Company Secretaries, of their wish to sell shares, should have already received a letter from me, with the registration form included for you to formally register your interest. If you have not received that letter, the form can be located on the website and downloaded from there. If you wish to purchase shares, you will also need to register your interest, so please download the form and send that through or drop it into the branch.

Once that is done, you are on your way.

One of the many advantages of the LVM is that you can see trading prices and quantities available 24 hours a day, 7 days a week. You don't need to wait for me or anyone else to contact you back, only to find we can't discuss those details with you anyway. Once people are registered, you will see something like this –

The identity of participants will be disclosed only to persons who register an interest.

There are two sections – Buyers and Sellers. You will see how many shares people wish to purchase or sell (Parcel) and the price they are prepared to pay or sell for. Once you are registered on the system, you will also be able to access the accompanying details of the buyer/seller so you can contact them directly and trade shares with them.

A letter will be sent out explaining everything to all shareholders (you should have already received it – if not please contact me). However please feel free to contact me directly at any time during normal business hours Monday to Friday, or contact the staff at our branch and they can pass your details on to me.

Riding develops abilities -Peninsula

Riding Develops Abilities (RDA) Peninsula is a voluntary, non-profit organisation developing ability and enriching lives through specialised programs and relationships with horses. RDA provides suitable horses, trained volunteers, accredited coaches and all equipment for therapeutic riding based programs that are tailored to meet individual needs and achieve goals. Apart from being lots of fun, riding and relationships with horses helps to build confidence, self-esteem, coordination, balance, muscular development, fitness, communication and encourages team work and leadership skills.

My daughter Hayley has been riding for four years and is now an independent rider. She rides each week, grooming and tacking up her horse before riding in the arena, the new round yard or on a trail. There is definitely an amazing connection between the rider and the horse that is quite profound. For Hayley, the initial focus of her riding was to strengthen her muscles and improve balance and coordination but the positive benefits and opportunities that have eventuated from RDA have been just so much more than that and flow on into all other aspects of her life.

All of this would not be possible without the wonderful volunteers and committee who not only work with the horses and riders within RDA programs but also care for the horses, maintain the property and equipment, train new volunteers and do everything else that goes along with this kind of organisation. And in turn, this would not be possible without the generous use of a private property in Balnarring and financial support from many individuals, businesses and community groups like Balnarring & District Community Bank® Branch, Dromana Lion's, Sorrento Rotary and Flinders Golf Club that have recently enabled RDA to open a new round yard. The round yard will enable more independent riding and further growth of an all abilities vaulting group. Our current plans to improve the Centre include covering the riding arena, a shed closer to the paddocks to store horse food and needs and improved signage at the front of the property and nearby access roads.
