Chairman's report



It is a great pleasure for me to contribute to my first newsletter since becoming Chairman of the Board. I am very excited about the opportunity to serve this wonderful community and I am looking forward to working with all key community groups and stakeholders as we continue to communicate the value and benefits of the **Community Bank**[®] concept.

I am particularly focused on driving new revenue streams that will bring increased profitability and shareholder value and I am looking forward to working more closely with our current shareholders in bringing in new business to the branch, as we need your help in our quest for increased revenues and long term sustainability.

We have received notification this month that Bendigo and Adelaide Bank Ltd has found it necessary to review the commission rates that they pay community franchises. The model was always based on equal responsibility and equal reward, however in recent years the actual revenue share has deviated from this principle, with the bank finding itself realising far less than the 50 per cent agreed.

This has been due to the regulatory responses to the Global Financial Crisis, which has exposed some aspects of the revenue share mechanism adopted when the **Community Bank**[®] model first started in 1998.

This imbalance must be corrected to ensure that Bendigo and Adelaide Bank is making adequate returns, thereby ensuring the bank is successful and maximising funding opportunities by improving its rating and maintaining access to capital.

It really is a matter of us being able to grow our businesses together. The new commission rate became effective on 1 April 2011 and will be 0.375 per cent for both term deposits and fixed rate home loans respectively for the next two years, at which time the bank will reassess the position.

Bendigo and Adelaide Bank has been totally transparent in this review process and has engaged Price Waterhouse Coopers to conduct an independent review of the revenue share model. The report has been made available to franchises

The Directors of Balnarring & District Community Services will continue to grow the business with more new initiatives to offset these reduced commission rates and our Business Plan is once again being reviewed to take these changes into account. We recently interviewed several candidates for the vacant Customer Service Officer position and we were amazed at the high quality of the candidates. This made our decision very difficult, but Wendy Hutchinson has been appointed and is already part of the team.

The Board of Directors of Balnarring & District Community Services currently has two positions vacant, and we would welcome expressions of interest from shareholders and members of the local community, who feel they have what it takes to be an active member of the Board. We build our business greatly from leveraging local networks and community groups, so if you feel you would like to be part of this great team please contact myself on 0417 106 998 and I will be happy to meet with you and discuss opportunities.
