Background

 - o Initiatives that support community resilience
- People and Social Impacts
 - o Initiative's that support diversity and equality, family and under privileged groups, reducing social isolation.
- Healthy Connected Communities
 - o Acknowledging best practice policy around health and wellbeing.

Grant Application Timelines

The Barwon Heads Community Bank offers two grant application rounds.

Round 1. Applications open on 1 January Applications close on 31 March	Round 2. Applications open on 1 June Applications close on 31 August
Applications are assessed and taken to the board for approval	Applications are assessed and taken to the board for approval
Applicants notified in May.	Applicants notified in October.

Tips for planning your grant application:

- Always apply with plenty of lead time before your event.
- Develop an annual funding plan with your club to ensure your grant applications fit in with the events you have planned throughout the year.
- Supply as much information as you can.

Conditions of funding:

- All applicants must be customers or Barwon Heads **Community Bank**® Branch
- Applicants must complete a Project Evaluation following their grant period
- Applicants agree to support Barwon Heads **Community Bank**® AGM by speaking about their project at the annual AGM.
- Applicants must consent to have their applications discussed in a strictly confidential manner by the board.
- Applicants must gain appropriate permissions for using children in photographs prior to their events.
- Funding is not guaranteed and the Board's decision is final.
