Dear Valued Shareholder,

It is my pleasure to update you on the results achieved by Beaumaris Community Financial Services Ltd in the first six months of the 2019/20 financial year.

Our strategy of focusing on our unique value proposition as a Community Bank continues to deliver a steady growth in profits as shown by the following results:

Size of Business	-2.6% to \$144.3 million
Income	-0.2% to \$376,721
Expenses [before allowing for Charitable Donations and Sponsorships]	-7.3% to \$298,915
Profit from Operations [before allowing for Charitable Donations, Sponsorships and Income Tax]	\$77,806 (vs \$54,997 last year)
Charitable Donations and Sponsorships	\$39,537 (vs \$10,268 last year)
Total comprehensive income for the year after retrospective adjustment upon adoption of AASB 16 on the treatment of leases.	-\$3,279 (vs. \$30,913 last year)
Customer numbers	+4.4% to 2,629

- **Size of Business:** Our business growth has levelled out and the Board remains focused on continual improvement across all aspects of our operations as we seek to diversify our income base. This is important as loans provide a longer term, higher yield income stream.
 - Loans grew by 8.3% and make up 21.6% of our total business compared with 19% last year
 - o Deposits fell by 3.0% but remain at 72% of our total business, and
 - Wealth and other business declined by 26% to account for 6% of our business, down from 8% in the same period last year.
- Revenue growth has been adversely affected by tighter margins and the decline in the size of the business.
- **Expenses** have fallen which has more than offset the small decline in revenue resulting in an increased profit.
