**Principal activity**

The principal activity of the company during the financial half-year was facilitating Community Bank services under management rights of Bendigo and Adelaide Bank Limited (Bendigo Bank).

**Review of operations**

The profit for the company after providing for income tax amounted to \$61,843 (31 December 2024: \$102,039).

**Significant changes in the state of affairs**

During the reporting period the company completed a refurbishment for the Buderim Branch, which also included disposing of old assets that were either replaced or no longer in use. Total cost of the refurbishment was \$110,652. As at balance date, the refurbishment had not yet been paid, with the amount recognised as a liability within trade and other payables.

There were no other significant changes in the state of affairs of the company during the financial half-year.

**Note 1. Basis of preparation**

These general purpose financial statements for the interim half-year reporting period ended 31 December 2025 have been prepared in accordance with Australian Accounting Standard AASB 134 *Interim Financial Reporting* and the *Corporations Act 2001*. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34 *Interim Financial Reporting*.

These general purpose financial statements do not include all the notes of the type normally included in annual financial statements. Accordingly, these financial statements are to be read in conjunction with the annual report for the year ended 30 June 2025 and any public announcements made by the company during the period.

The accounting policies adopted are consistent with those of the previous financial year and corresponding interim reporting period, unless otherwise stated.

**Note 2. Economic dependency**

The company has entered into a franchise agreement with Bendigo Bank that governs the management of the Community Bank. The company is economically dependent on the ongoing receipt of revenue under the franchise agreement. The franchise agreement expires in March 2030.

The directors have a reasonable expectation that a new franchise agreement will be signed prior to the expiry date.

## Report on the half-year financial report
