However, each year a number of shares are traded due to change in shareholders circumstances such as moving from district, death, family reasons and the necessity to free up cash. Fortunately to date there has been a ready market for anyone wishing to sell for whatever reason. In fact at this time there are no sellers listed and six buyers for various sized parcels. As Directors we must point out we cannot offer advice to any enquiring buyer or seller of shares as to what they should ask if selling, or pay if buying. This has to be negotiated by the parties themselves. The best way to monitor share trading is to go online to the Bendigo Bank website, then to Community Bank® branches and to our Creswick & District Community Bank® Branch. Under the Investor Relations heading you are able to see what parcels are for sale, latest transfers and what buyers are prepared to pay.

This method of Share Trading is called operating on the Low Volume Market. You can download the applicable forms necessary or in fact fill out on line. If in doubt our staff can provide direction. Sales over the past two years have been in the range of \$1.20 to \$1.70.

So, should your circumstances change and you wish for whatever reason to sell your holding this may be of help.
