At our recent AGM Chairman, Graeme Mitchell made a couple of significant announcements and rather than steal his thunder, I suggest you read his report in this newsletter if you haven't already done so.

We welcome Rhonda Lowe to our staff (see staff profile) and wish her every success in her role as Customer Relationship Manager. In the short time she has been with us, Rhonda has shown that she is going to be a very valuable staff member in helping us achieve continued growth as we move into the future.

We have been working on the production of a new brochure which will promote our **Community Bank**<sup>®</sup> branch. We intend to distribute the brochure to all households in the Creswick and Clunes districts.
