# Ag information night.

On Wednesday 24 August Edenhope & District **Community Bank®** Branch, in conjunction with Rural Bank ran an Agribusiness Information Evening. The evening was a huge success with 80 people attending. As part of the evening we had two guest speakers.

The first one was Tim Leeming who is a farmer from Pigeon Ponds. Tim spoke about his role as Chair of the Southern Australian Meat Research Council and his role as Group coordinator of Best Wool/Best Lamb and lifetime ewe management programs. Tim then went on to tell us about his own farm and what he is doing to improve his farming enterprise, focusing on better lambing rates, and making his farm more efficient.

Our second speaker was Matthew Ough, who grew up in Edenhope and now works for Rural Finance researching and writing the Ag Answers newsletters and publications. Matt spoke about the Australian Farmland Values index and the data he works with show what farmland values have done in the past and are likely to do in the futures, and what factors can contribute to the decline or increase in property prices in Australia. Matthew was able to show the audience graphs and information relevant to our local area. Matt also quickly touched on commodity prices.







Both guest speakers provided the audience with great information and ideas, and this is something we are looking to run again in the future.
