#### **Sponsorship Application**

#### **Information for Applicants**

The Swansea/Bicheno Community Bank is operated by **Freycinet Coast Financial Services Limited** (**FCFSL**), a community-owned Company which dedicates a significant portion of its profits to supporting the local community.

**FCFSL** offers two funding streams which aim to make targeted use of funds for the benefit of the community, contributing to the development of community welfare, environmental, health, education and arts or cultural areas

- a Community Small Grants Program which provides funds to meet specific one off needs of charitable or not-for-profit organisations and
- a Sponsorship Program, which provides an opportunity for a longer term relationship providing mutual benefits for the organisation, the Bank and its clients.

#### Where does the money come from?

The Bendigo Bank products available through the Branch are the Company's main form of income and part of the profits made are returned to the Swansea/Bicheno **Community Bank**® Branch Grants and Sponsorship Programs. As the banking business grows so too will these Programs and the Company will be able to support more community groups.

#### **Sponsorships**

A sponsorship is a partnership agreement between the Bank and a club or organisation which provides mutual benefits to the organisation and to the Bank and its clients **and** which provides publicity opportunities which allow the **Community Bank**® Branch to grow its business. The more successful the banking business is, the more funds can then be returned to the local community.

#### **Sponsorships must**

- Create tangible benefits to the wider community
- Support local initiatives that have long lasting positive benefits

#### Sponsorships must not

- Promote political or religious organisations
- Denigrate or offend any other groups in the community
- Result in environmental destruction or animal cruelty
- Present programs that may create hazards to the community
- Present programs that do not reflect community standards
- Present programs sponsored by Swansea Bicheno Community Bank® competitors
- Advocate gambling or alcohol
- Require the use of or promotion of weapons

#### **Applications**

Applications for financial support up to \$1000 p.a. must be made on the form provided and will be subject to negotiation between the applicant and the representatives of the FCFSL Board and subject to the approval of the Board. Success of an application may also be limited by the funding available at the particular time. Applications should indicate:

- Benefits provided by the sponsored organisation
- Current level of support for the Community Bank® demonstrated by the applicant
- Locality of club or organisation

#### **Memorandum of Understanding**

Each sponsorship agreement entered into by the Bank will be negotiated separately and the responsibilities/duties of each partner will be detailed in a Memorandum of Understanding agreed to and signed by their representatives.

#### **Permission Forms**

As part of the Reciprocal Support Arrangements, a *Permission to Publish Sponsorship, Intellectual Property and Copyright Release* and *Photography Consent* form is attached for applicants to sign and have witnessed.

#### **Tax Invoice**

If your application is successful a Tax Invoice will need to be returned to the **FCFSL** Treasurer each year in order for you to receive your funding. The details required on the invoice may be subject to agreed clauses in the MOU. You will find a Tax Invoice form attached to your notification letter.

#### **Acquittal Report**

All sponsorship recipients are required to complete a Sponsorship Acquittal Report at the completion of each year of the program. This will then be used to assist in measuring the success of the sponsorship.

#### **Privacy**
