It gives me great pleasure to announce the hard work of staff together with the continued support of our shareholders and customers has resulted in ongoing strong monthly profits for our **Community Bank®** branch.

We have returned \$350,000 to the community by way of sponsorships and grants in addition to \$80,000 in dividends to shareholders.

We are now in a position to seriously consider contributing to larger, perhaps more ambitious community projects – perhaps undertaken in conjunction with local, state or federal government. We are open to and need your ideas.

On behalf of the Board, I would like to acknowledge and express our sincere thanks to Allan and Dianne Bunnet for their roles as Treasurer since the Inglewood & Districts Community Enterprises Limited was founded and wish them well in the future.

The closure of the ANZ Branch in Wedderburn has resulted in a strong local push for a **Community Bank®** branch in that community.

With the guidance of Bendigo and Adelaide Bank Ltd, a steering committee has been formed and the pledging process is well under way. It has been agreed \$600,000 in pledges and \$10 million in banking business would be needed for a **Community Bank**® branch to be viable.

The Wedderburn community would then have its own franchise agreement with Bendigo and Adelaide Bank Ltd and be operated as a second site of Inglewood & Districts Community Enterprises Limited. There would still be the one Board of Directors with the aim to have two banking sites working together rather than two separate banks in competition.

There remains much to be done and in the meantime we continue to improve and build upon the services already provided to Wedderburn by way of our agency at Randall's Supermarket.

On behalf of the Board I thank you for your continued support and look forward to your ideas, criticisms and suggestions.

It has been my pleasure to be involved with the Inglewood & Districts **Community Bank®** Branch which has sponsored the Driver Education Project.

The program provides a wonderful opportunity for Learner drivers to access professional driving instruction and is targeted to meet individual needs.

The program is made up of:

- six hours of one-on-one instruction in a manual or automatic car with dual controls
- six hours of shared instruction (2 students at a time), providing instructor, passenger and driver opportunities for observation and discussion, including theory and rules of the road, based on the Learners' Handbook
- giving each student a total of nine hours supervised driving time which is eligible to go towards the 120 mandatory Logbook hours required by VicRoads.

On completion of the course, students are presented with a certificate.

To date students have come from Wedderburn, Inglewood, Newbridge, Serpentine, Fentons Creek, and Berrimal.

As instructor, I have been impressed by the enthusiasm of the participants and they have all expressed their appreciation and thanks to the Inglewood & Districts **Community Bank®** Branch for the opportunity to join the program.

Stock exchange listing changes

Inglewood & Districts Community Enterprises Ltd is currently listed on the National Stock Exchange (NSX) – formerly the Newcastle Stock Exchange. The Bendigo Stock Exchange (BSX) no longer lists **Community Bank**® branches and has changed its name.

The benefits of being a listed Company include enhanced disclosure of Company financial and governance affairs to the public and transparent trading in Company shares. There are costs involved in both the listing and the enhanced disclosure in the order of \$6,000 plus per annum.

The Board of Directors of the Company are considering whether to continue to list the Company or to delist. Delisting will save costs, but may make buying or selling Company shares a little more difficult for shareholders or prospective shareholders.
