


Welcome.

After returning from this year's NSW State conference we have spent time at our last few meetings discussing this and as a result have resolved to not call for grant applications this year.

We feel it's a good time for this as there are a few major projects on the horizon. As an example the Board's Sponsorship/Grant Committee recently met with the Manager of Technical Services of the Lockhart Shire Council to discuss the future of the Lockhart Swimming pool.

Also later this year we will be giving the Lockhart Football and Netball Club \$45,000 that was pledged to them back in 2012 to help build new netball courts.

We are very mindful that these larger grants will be to organisations that will improve facilities for the district in general.

It is also important to note that we will continue to support and sponsor four local football clubs as well as The Spirit of The Land, Lockhart A&P Society, Lockhart Picnic Race Club etc.

To date our Lockhart & District

Community Bank® Branch has given out an amazing \$773,844 in grants to local community groups/organisations as well as a total of \$407,009 in dividends back to shareholders of our

Community Bank® company. This is over \$1 million in money that would have otherwise left our community. We look forward to continuing to support our local district well into the future.
