

Chairman's report.

Welcome to our mid-year newsletter for 2017. This newsletter is to let you know some of the things that have been happening at your **Community Bank**[®] branch.

Recent community grants.

On Friday 3 March we combined our Annual Community Grants Night with Lockhart Shire Councils Back to Business Week evening with guest speaker Tom O'Toole from Beechworth Bakery fame. A very successful event was held with over 90 people in attendance. Grants were awarded to the following organisations:

- Lockhart Pre School Kindergarten \$10,000 towards toilet renovations with disabled access
- St Francis Xavier School Urana \$4,000 towards purchase of new ride on mower
- · Lockhart Aqua Fitness \$3,000 for exercise equipment
- Lockhart Progress Assoc \$5000 towards shade sails at children's playground in Walter Day Park
- Explorers Rifle Club \$5,000 to purchase a ride on mower.
- Urana Campdraft \$3,000 to purchase demountable seating to be used at Victoria Park.

These community grants amounting to \$30,000 bring the total amount of grants to district organisations' projects and clubs to \$830,000 since we opened the branch in 2002. Shareholders have also benefited by \$450,000 which we have paid out in dividends.

In addition to the above grants we have also pledged the amount of \$25,000 to the Lockhart Shire Council to assist them in their applications for funding to build a new swimming pool for Lockhart and district.
