Camp Awakenings.

For the fourth consecutive year Bendigo Bank has proudly participated in the Camp Awakenings (CA) Program to send regional students to a life-changing leadership camp.

Elmore/Lockington/Rochester **Community Bank**[®] branches sponsored two year nine students, Jordon Evans and Jasmin Malham, from Rochester Secondary College, to attend Camp Awakenings during the last weekend in August 2017.

Senior Branch Manager Tracie Kyne said the sponsorship was part of Elmore/Lockington/Rochester **Community Bank**[®] branches' commitment to empowering young people in this area.

"Camp Awakenings is an Australian youth development program for year nine students. The Camp provides its participants with a supportive environment to grow and develop," Tracie said.

Camp Awakenings is focussed on building leadership skills and support networks for the participants through friendship and trust," said Brad.

"This is yet another example of the outstanding benefits to our students and school more generally.
