Community Sponsorship Program

We are very proud to announce our recipients of the 2020 Community Sponsorship Program. We awarded 15 groups with financial support for their programs.

The Lockington Landcare were successful in obtaining funds that will go towards an upgraded weather station and soil probes. This project will help farmers and contractors make better decisions by providing access to accurate information about rainfall, humidity, moisture retention, soil temperature, Delta readings (important information for spraying) and the new fire index rating. This new 'Fire Model' uses wind speed and direction as a basis for the Grasslands and Fire index. This is a \$12,000 project with the Community Bank Elmore, Lockington and Rochester proudly donating \$5,000. Congratulations to all at Lockington Landcare for their efforts in bringing this project to fruition.

Elmore Ladies District Auxiliary was awarded a financial contribution towards their Community Transport Program, which has seen the purchase of a new car for the community. Our contribution of \$2,000 per year for the next three years will go towards the annual running of the car including insurance and registration.

Rochester Mural Festival is being supported to construct additional Mural Shelters. This \$10,000 project will receive a Community Bank contribution of \$1,264, which has gone towards the purchase of boards

for the stands. These stands will help display and protect the prize winning artwork into the future. Congratulations to the committee on their sustained efforts to make this event a special part of the Rochester arts program.

Did you know?


At Lockmore Financial Services Limited 15 year celebrations in 2018, we gave away \$15,000 each to a local community group in Elmore and Lockington for a project that could be built upon.

Elmore's Progress Association is utilising the money to refurbish and reinvigorate the Senior Citizens building. The building will be open to the public and will be the new home for Lockmore Financial Services Limited administration centre. Painting, new blinds, carpet and more will give the centre a fresh appeal for locals visiting the centre.

Lockington's funds are going towards the upgrade of the walking track through the plantation area in Forrest Street as well as providing the upgrade of the channel boardwalk in the centre of town.

Walking tracks will be extended to meander around the inside of the perimeter fences of the plantation area. Tracks will be gravelled whilst the natural character of the area will be maintained, leaving existing ground cover and some fallen timber for insects and reptile habitat. Seating and tables will be scattered throughout the plantation area once ground works are completed.

The boardwalk over the channel in the Deakin Street area has had some of the wooden planks replaced. This provides safe access to the Lockness monster and the gazebo, a great place to sit and relax in town.



In Rochester, Lockmore Financial Services Limited has contributed \$20,000 to the Rochester Community Economic Development Plan. This plan identified 19 local projects that would be of economic value to Rochester. Our funding was directed through to the Open Spaces Strategy and the Arts Culture Strategy. At a recent Campaspe Council meeting the Open Spaces strategy were awarded \$310,000 to adopt the concept plan for Rochester Rotary Park and construct in 20/21 capital works projects.
