## Rochester campaign for a **Community Bank**<sup>®</sup> branch

We wish to advise shareholders that your **Community Bank**<sup>®</sup> Company - Lockmore Financial Services Ltd, is investigating the potential of a 3rd branch to be opened in nearby Rochester.

A Steering committee comprised of interested members of the Rochester community was formed in conjunction with the Board of LFS in November 2009, to investigate the possibility of this expansion of our business.

Following the impressive level of interest from this Steering committee, the campaign for a **Community Bank**<sup>®</sup> branch for Rochester was launched in February 2010.

To date, over \$500,000 has been pledged toward the target of \$600,000 to provide the required start up capital for a 3rd branch.

Moving forward, the process will follow the same lines as for the opening of the Elmore and Lockington branches which opened December 2003 and March 2004 respectively.

### Fuel Project update

All shareholders recently received a North Central Victoria Community Fuel Project newsletter entitled 'Community Fuel News' (May 2010).

This is the fuel project that has been operating under the 'umbrella' of Lockmore Financial Services Ltd since early 2009.

A pledge campaign has been underway for this fuel delivery business to become an integral part of our expanded business. Fuel deliveries have been occurring for the past 2 years, and the plan is to expand by installing fuel storage tanks to be located in the area.

As you will have read, the storage facility is to be placed at the Goornong depot of 'Gilmac Pty Ltd.'

The profits already being raised from the fuel delivery sales will more than double with continued over page

the addition of this local fuel storage, which will build yet another opportunity for an 'income stream; where again funds from these profits are to be returned to the community.

So by simply purchasing your bulk fuel supply through this branch of our Company, you are not only obtaining a supply of quality petroleum products but also contributing to the wealth of the entire community.

The fuel project has recently benefited through the receiving of a grant from the Victorian Government. Under its Regional Infrastructure Development Fund we successfully applied for \$230,000 to help with the costs of constructing the fuel depot. This will be a great help to ensure we complete construction of the depot as quickly as possible.

All the different components of this project are now coming together to ensure we have a successful, profitable addition to Lockmore Financial Services Ltd's balance sheet. The prospectus will be released very soon, but in the mean time why not consider us for your next delivery of fuel?
