Welcome to our Newsletter for 2017.

The branch is approaching its ninth birthday and is now a well-established and respected corporate citizen of the Macedon Ranges.

To our foundation shareholders, thank you for your vision and faith in backing the establishment of our branch. To our more recent shareholders welcome, and thanks

for supporting our company that in turn benefits the community we live in, in so many ways! Macedon Ranges Community Enterprises Ltd is now paying a sound dividend return in addition to significant community investments across a broad spread of activities within our community.

There have been a number of changes in the branch since our last newsletter and our Annual General Meeting in November 2016. We welcomed Jane Lincoln as our new Branch Manager in March, Sarah Barton has returned from maternity leave and other staff have changed job descriptions. On behalf of Directors, I thank all our staff for their efforts over the past 12 months. They are a great team and continue to deliver excellent customer service to our clients.

Over the past year the Gisborne & District **Community Bank**<sup>®</sup> Branch has transitioned through a revised revenue sharing arrangement with Bendigo Bank. While this has altered our income streams it has had a marginally positive effect on our share of revenue. I am pleased to report our business footings now exceed \$150 million, and our cash reserves (including funds held on our account at the Community Enterprise Foundation™) now exceed shareholder funds. Our business pipeline is steady and Directors see no reason why our business will not continue to grow and prosper despite difficult trading conditions experienced across the banking sector at present.

As a result of continued profitable trading and a sound financial position, your Directors are pleased to announce a fully-franked dividend of 7 cents per ordinary share for the year ended

30 June 2017, to be paid late November 2017 to all shareholders who were registered at 5.00pm on 31 July 2017.

Your Directors conducted a company review session in May and are currently refining our policies to address the fact that the company has moved from its establishment phase to a more mature and well-established local business. You will have observed a number of community investment announcements in local media. I would encourage you to follow Gisborne & District **Community Bank**<sup>®</sup> Branch on Facebook to keep abreast of the latest investments. Some to note are:

- A \$40,000 investment to allow the establishment of a Mental Health & Wellbeing Centre within Macedon Ranges Health.
- Joint major sponsor of the Macedon Ranges Business Excellence awards along with Romsey, Lancefield and Kyneton Bendigo Bank branches, encouraging small to medium businesses within our region.
- Establishment of a Disaster Relief Fund to be instigated in association with Macedon Ranges Shire Council should a disaster be declared in our region.
- Awarding of another three-year tertiary scholarship to a deserving local student and funding another secondary student to attend national Magic Moments summit in Sydney.
- A raft of other grants and financial support offered to a wide range of sporting and cultural groups across our region.

## Mental Health Hub for Macedon Ranges Health.

Improving mental health and wellbeing is an urgent priority for the Macedon Ranges. As a result, Macedon Ranges Health (MRH) will be opening a new Mental Health & Wellbeing Hub at the MRH Centre in Lyell Street, Gisborne. Work commenced on the \$80,000 project in August and the new hub is expected to open in October 2017.

The hub will comprise four new consulting rooms and a meeting space to expand the delivery of counselling, psychology, social work and family violence programs offered in the centre. The hub will also support the delivery of workshops, classes and community programs to support better mental health and social inclusion across the region.

Gisborne & District **Community Bank**<sup>®</sup> Branch contributed \$40,000 towards the new Mental Health & Wellbeing Hub. Chairman Graham Stewart said the significant investment reflects the importance of the project to our community. "Individual wellbeing is vital for the wellbeing and success of our community as a whole. We are privileged to be able to contribute to this health sector by supporting our local community health provider, Macedon Ranges Health, in delivering additional mental health and wellbeing services to our area," he added.

Macedon Ranges Health CEO Don Tidbury said, "The organisation is very grateful for the ongoing generous support Bendigo Bank has provided to assist MRH to support the

vulnerable and the aged in our community." In addition to the new \$40,000 investment, the branch donated a Toyota commuter bus to Macedon Ranges Health in 2015 that is used daily to bring frail and elderly persons to the centre for programs and services and take residents of The Oaks Aged Care into the community. It has also been the major sponsor of MRH's annual Colour Run since the community event began in 2015.



## IT Upgrade for Fire Brigade.

Riddells Creek Fire Brigade purchased new computer screens and a new printer in July thanks to a \$900 branch community investment. Captain Tom Morley said the brigade is very grateful for the bank's support. "The new IT equipment has better positioned the brigade to create and print community educational information, operational mapping and briefing for fires and controlled burns, and reduced our reliance on members' personal computers," he added.

Chairman Graham Stewart visited the fire station to view the new equipment and thank the volunteers for their service to the community. "Riddells Creek Fire Brigade does so much for our community. It is a privilege for us to be able to support them through our community investment program," he said.

Gisborne & District **Community Bank**<sup>®</sup> Branch is a strong supporter of local emergency services. We funded new chainsaws for the Mt Macedon Fire Brigade in 2015, iPads for Gisborne SES in 2014 and an all-terrain wheeled stretcher in 2016.

## Scholarship update.

As our business grows, we have been able to extend our scholarship program for talented local youth. At the beginning of the year we awarded our 2017 university scholarship to Eshe Lane of New Gisborne. The bursary is worth up to \$15,000 over three years. Eshe completed Gisborne Secondary College last year and is now studying Public Health/Global Studies at Australian Catholic University. She is also doing a Diploma in Spanish.

Eshe is the branch's fourth university scholarship student. Moyra O'Donoghue (2014) is due to complete her Education studies at La Trobe Bendigo this year, Jessica Li (2015) is in her third year of Science at La Trobe Bendigo, and Kirsten Lanyon (2016) is in her second year of a Bachelor of Human Services at La Trobe Bundoora.



The branch will offer another tertiary scholarship in 2018 and plans to broaden the eligibility to both university and TAFE. Details will be available by November.

This year we introduced a scholarship for a local youth to attend the Magic Moments Youth Leadership and Business Summit. This is a five-day annual camp attended by over 200 people aged 12-21. Gisborne Secondary College Year 11 student Polly Reid was awarded the scholarship and attended

## Community infrastructure investment.

Play at Ross Watt Reserve in New Gisborne reached new heights this year with a rope-climbing frame suitable for all ages installed in March.

In December 2016 New Gisborne Tennis Club received a community investment of \$5,900 for new playground

equipment at the reserve next to the courts. The club combined the funds with a Shire Community Funding Scheme grant to purchase this major piece of new equipment.

New Gisborne Tennis Club Secretary Robyn Johnston said the equipment has invigorated the ageing reserve and benefitted the tennis club, neighbouring Chessy Park, and New Gisborne Primary School that uses the reserve for Physical Education.

The branch is delighted to have helped upgrade another community space that will be enjoyed by local residents for years to come. Other community infrastructure projects the branch has enabled include a double flying fox at Lions Memorial Park in Riddells Creek, a lighting upgrade and electronic scoreboard at Gardiner Reserve and the pavilion at the Regional Netball Complex in New Gisborne.
