Dividend for shareholders

277 Mansfield community members, who supported the Mansfield & District **Community Bank**[•] Branch since its inception in 2007, received their first dividend in December 2012.

Shareholders each received a share of \$30,226.40, the total dividend, based on four per cent of 755,660 shares issued at \$1 each.

The first dividend of four per cent resulted from two years of profitable trading by Mansfield & District **Community Bank**[®] Branch, following the recouping of start-up costs.

The Directors of the **Community Bank*** company decided the dividend was a fair reward to all the shareholders who initially funded the establishment of the branch and who have been patiently watching its development over the past five years.

The result was a culmination of a lot of hard work and local support from the Mansfield and surrounding community and sincere thanks was extended by the Chairman and Directors of the Board.

More funds contributed to the Mansfield & District Community

A funds distribution morning tea was held at the Mansfield & District **Community Bank**[®] Branch during early April to award funds to local organisations who were successful in the Mansfield & District **Community Bank**[®] Branch funding program.

Successful applicants included:

- Mansfield Historical Society Digitalisation of Still & Moving Images
- Up2Us Landcare Alliance Tree Planting along the Rail Trail

Funds distributed for this round of funding were \$17,000, taking the total amount of funds contributed to the Mansfield and district community to almost \$200,000.

In addition, \$3,000 in seed funding was ear-marked for the Merijig Public Hall, to go towards installation of a fire safety sprinkler system. The funds will be held for three years for the Merijig Hall to leverage additional funding. All applicants were congratulated by the Chairman Marian Dowling and the branch's supporters were praised.

It is only with the support of shareholders and customers that the Mansfield & District **Community Bank**[®] Branch can provide the funding program, which contributes much needed funds to local community groups, clubs and not-for-profit organisations.

Chairman's update

Mansfield & District Community Enterprises Limited is well into its fifth year of operation and it is now time to review and re-assess many of the processes and procedures that were put in place when the branch was in its infancy. At the State Conference in Bendigo earlier this year two items were high on the agenda for discussion – succession planning within the branch and the Board, and the need for a Strategic Plan. Statewide, Mansfield is recognised as a leader in these two areas, and I was asked to facilitate planning sessions on these topics during the Conference. I am pleased to report that during May all Directors and Staff attended workshops to revisit our existing Strategic Plan, considering our goals for the next four years and developing business strategies to achieve these goals on your behalf.

Last year, we restructured the way we assess and deliver the branch's funds into the community. This process has been most successful, with two funding rounds per year proving to be efficient and providing community groups the opportunity to plan their application more thoughtfully and budget the expenditure on their chosen project.

Regrettably, Director Phil Alexander has tendered his resignation as he and wife Pam have returned to Melbourne.
