## AGM

Our annual general meeting was held at the Calwell Club during November 2009. The AGM saw a number of changes for your local **Community Bank**<sup>®</sup> branches.

### Change of name

Due to our expansion out of the Tuggeranong Valley, our community Company has changed its name to Molonglo Financial Services (MFS). The new name better describes our expanded regional presence while still retaining a local focus. The change was supported by the shareholders at the last AGM.

### Increase of Director numbers

Over the years the Board has expanded to 10 Directors, the maximum allowed under our constitution. Subject to a successful share float for our third site in Jerrabomberra, the Board received the approval of the shareholders to allow for two additional Directors.

Also at the AGM, guest speakers from the Jerrabomberra area spoke about how the grants provided to them by MFS have been spent and dance group KultureBreak performed for the shareholders entertainment.

Peter Strong farewelled Branch Manager Ray Haley and thanked him for his seven years service. Peter also introduced new Calwell **Community Bank**<sup>®</sup> Branch Manager, Debbie McLellan and Wanniasa **Community Bank**<sup>®</sup> Branch Manager, Toby Mahoney.

## Community contributions

One of the biggest differences between a **Community Bank**<sup>®</sup> branch and other banks is your local branch reinvests its profit into the community through dividends to shareholders and grants to community groups and projects.

This year we made our largest single donation to date. Thanks to our \$50,000 donation, Canberra based charity, OzHarvest, has added a new refrigerated van to its fleet.

OzHarvest rescues excess food from restaurants, stores or institutions, which would otherwise be discarded. This excess food is distributed to charities supporting the less fortunate.

The keys were handed over in February 2010 at a small ceremony at the Wanniasa **Community Bank**<sup>®</sup> Branch.

In addition your **Community Bank**<sup>®</sup> Company has supported:

- Kulture Break - we donated \$36,000 over two years towards sponsoring their schools program in southern Canberra,
- Tandem – we have committed to providing \$10,000 per year over three years towards their carers' vacation program.
- Autism Aspergers ACT – we have contributed more than \$11,300 towards the sponsorship of their last two annual charity dinners.
- ACT Veterans Rugby Union – we have contributed \$6,000 in sponsorship to Clare Holland House palliative care for the last two years.
- Sids and Kids - we have donated \$9,950 over the last two years and a further \$1,000 to purchase 50 tickets to their movie night. We then gave the tickets to Autism, Fabric and Sids and Kids so some of their volunteers could attend.
- We are active in the schools providing breakfasts, fete prizes, purchasing of new equipment, sponsoring of events.
- RSPCA - this year's partnership will result in an additional \$15,000 to assist them with their valuable work.
- Tuggeranong Child and Family Centre – we provided \$12,000 in funding to deliver a series of parenting expos with various multi-cultural groups in the Tuggeranong Community.
- We donated \$1,000 to Sponsor the ACT Emergency Services Awards.
- Neighbourhood Watch – we provided \$5,000 to assist Neighbourhood Watch in the Tuggeranong area.
- ACT Down Syndrome Association received \$900.
- ACT and Eden Monaro Cancer Support Group – sponsorship of annual charity dinner \$4,600.

More recently we have contributed a further \$5,000 to ten community groups, schools and residence associations in Jerrabomberra.

## ATMs

With the rapid growth of our customer base it has become apparent that ATM access for Bendigo Bank customers in the ACT has been limited.

To combat this, new machines have been installed at DFO, Gungahlin Town Centre, Woden Westfield (to be installed by April 2010) and the new Company owned branch at Jamison. We are in regular discussions with our regional manager to plan the continued expansion of the ATM network to best serve our customers.
