### We are on the move!

### Our growth continues

As of 30 September 2020, we have experienced the following growth:

	30 June 2020	30 September 2020
Footings	\$157.49 million	\$167.80 million
Deposits	\$80.52 million	\$87.30 million
Lending	\$75.50 million	\$78.93 million
Other facilities	\$1.47 million	\$1.57 million

That's a growth of \$10.31 million (6.55%) for the first three months of this financial year against a budget growth of \$2.34 million. Considering the challenges that the whole community has faced this is a great start to the 2020/21 financial year.

Our staff continue to work under COVID-19 restrictions, which limits the number of customers we can have in the branch at any one time. I thank them for how they have provided high levels of customer service during this time.

With Christmas fast approaching we all look forward with great anticipation to further easing of restrictions and a COVID-19 normal that we can all work with and hopefully allow time together with our families.

I look forward to our move to new premises and what the last quarter of 2020 might provide.
