Manager's report

As we reflect on 2022, we have had several challenges with staffing, mainly due to COVID-19 and flue illnesses, which has caused the branch to close for lunch on occasions. We are now operating with the following opening hours:

Monday to Thursday: 9.30am to 4.00pm Friday: 9.30am to 5.00pm

Notwithstanding these challenges, I am very pleased to report that, our Growth continues – see table below.

As of 31 December 2022, we have experienced the following growth:

That's a growth of \$11.73 million YTD (5.20%) for the first half of this financial year, which is a great result, and we are fast approaching the \$240 million milestone.

Funding for local not-for-profit groups has continued to grow with the 2022 financial year reaching \$113,000. Year to date we have funded \$110,000 to local community groups with our budget increased to \$180,000 for this financial year.

This included all our local sporting clubs and community run groups We supported two very successful charity golf days run by:

- · The Rotary Club of Mt Martha
- · Mental Health Safety Net Inc.

Our support included:

- Local CFAs at Mt Martha and Moorooduc were supported for the very important work they do in keeping our communities safe
- The local Probus, Men's and Women's clubs to assist continue the wonderful work they do in our communities
- South Mornington Pre Schools received funding for musical equipment for their outdoor play area and Mt Martha Pre School funding for three community engagement initiatives they are running this financial year
- The Fusion Gala Dinner was another big event we supported, along with the Fusion Sleep in Your Car night, which saw all our staff sleeping out overnight in support
- 2022 Mt Martha Carols by the Bay An annual iconic Christmas event.

We held our AGM at Mt Martha Bowls & Pétanque Social Club in November 2022 which presented our performance for the 2022 financial year.

In summary our fundings are spread across many areas of our community, which we enjoy the engagement with local volunteers who help make these groups so successful.



Our community funding has grown from \$35,000 in 2020, \$80,000 in 2021 and \$113,000 in 2022. We have set our 2023 financial year budget at \$180,000 and have also launched our Mt Martha Stronger Community Grant Programme on 25 October 2022, which closed on 18 January 2023. \$200,000 had been allocated in funding for this grant programme, which the Board has now increased to \$250,000. We look forward to what applications we receive and how this funding will make Mt Martha a stronger community.

We hope everyone has had a very enjoyable Christmas and been able to catch up with family and had a very Happy New Year.
