How quickly has the last six months gone and who would have envisaged what 2020 was going to bring.

Having taken over as Manager when Kerry Debernardi retired on 31 December 2019, I am extremely pleased to be able to give you a brief summary of how we have performed as Mount Martha Community Bank in the 2019/20 financial year.

Lending	\$46.63 million	\$75.38 million
Other facilities	\$3.09 million	\$1.49 million

That's' a growth of \$47.50 million (41.32%) for the year against a budget growth of \$7.5 million. Considering the challenges that the whole community has faced this is an amazing result.

I wish to thank all our staff who have helped achieve this outcome and the local community for supporting Mount Martha Community Bank.

This growth will result in increased income, which in turn will be reflected in greater ability to fund future contributions to the local community and dividends to all our shareholders.

I look forward to providing greater detail when our 2020 Annual Report is prepared and sharing this information at our AGM later in the year, hopefully in person.
