Conditions of Funding

The Mount Martha **Community Bank**® funding will only be provided to organisations. These organisations must adhere to the following criteria:

- · operate in the Mount Martha district;
- be of a not-for-profit nature;
- maintain an active banking status with Mount Martha Community Enterprises Ltd
- not have funding from any other financial institution
- be able to demonstrate that they are viable and have a sound committee structure
- identify a clear and well planned use for the funds and that the funding will provide broad community benefit and involvement

In receiving funding, organisations should understand that they are entering into a business relationship whereby reciprocal benefits are returned to the Mount Martha **Community Bank®**, the sponsored group and the community and must therefore agree to:

- attend the allocated funding awards ceremony in either April or October;
- provide the Mount Martha **Community Bank**® with a receipt evidencing payment of the funding within 5 business days of receiving funds;
- only use the funds as outlined in the relevant application form:
- spend the allocated funds within 12 months of receipt;
- report on the use of the funds within 12 months of receipt;
- return any funds unused in the 12 month period;
- provide mutually agreed opportunities to promote the Mount Martha Community Bank® to stakeholders through speaking engagements, etc;
- include the Mount Martha Community Bank® logo in your organisation's promotional material, website & Facebook;
- ensure that any person associated with the organisation consents (or has a parent/guardian consent on their behalf) for their image or likeness to appear in media;
- receive correspondence from the Mount Martha Community Bank®; and
- participate in any surveys conducted by the Mount Martha Community Bank® regarding the funding.
