On behalf of the Board of Mt Eliza Community Enterprise Ltd, I am writing to give you early notice that our Annual General Meeting will take place on Monday 19 November 2018 at the Mt Eliza Bowling Club. A formal Notice of Meeting will follow within the next few weeks with our 2018 Annual Report.

The main reason for this letter is to advise that we are delighted to announce that the Directors will be recommending to the AGM that the company pay its first dividend.

The proposed dividend is 5 cents per share to be payable to all shareholders registered as at 1 October 2018. The dividend will be unfranked and we anticipate that it will be paid on 14 December 2018.
