We provided a \$10,000 grant that funded the creation of a new STEM Lab at Sacred Heart School, transforming an outdated ICT room into an innovative, hands-on learning space. Equipped with 3D printers, VR headsets, and experiment kits, the lab fosters critical thinking, problem-solving, and curiosity in students. Over 160 students now benefit from STEM-related learning experiences, preparing them for future academic and career paths.
