Community Bank Mundaring is proud to support our community through our Investment Funding program. Like you, we have a strong emotional attachment to our community.

We love the idea that local people own the Community Bank Mundaring and that by banking with us, profits earned are re-invested back into our Community. Decisions about where these profits are spent are made at this grass roots level. The amount of Investment Funds available to the community relates directly to the amount of business our locally owned Community Bank does.

Since opening in early 2002 we have distributed over \$2.5 million back to the community. As the number of banking customers grows, so too does the capacity to invest in more organisations in the future.

Our Community Investment Funding pool is limited and requests for investments always exceed our available funds so applications are considered on their value to our community. In some cases you may be offered a lesser amount.

Please note for certain applications it is possible that a second application form will need to be

completed to meet the requirements of our Community Enterprise Foundation.

What is a Community Investment?

In general terms, a community investment is a partnership where funding is provided for a club, group or individual that benefits both the local community and provides exposure and opportunities for the Community Bank Mundaring to spread the word on how Community Banks differ from mainstream banks and directly benefit the local community.

Objectives

We look for community investments that are mutually beneficial. The funds we are able to distribute back to the local community relate directly to the success of our banking business. In other words, the more banking business we have, the more funds we can invest into our local community.

Community Bank Mundaring offer a full suite of financial products like other banks BUT our big difference is that the majority of our profits stay right here in the HILLS.

Organisation/Individual name: What is the application organisations or associations full name? If you are applying for personal investment, put your own name here. Please note that Community Bank Mundaring usually invests in organisations rather than individuals since this widens the community benefit.

ABN: All applicants for community investment funds from Community Bank Mundaring must quote an Australian Business Number (ABN) otherwise in accordance with the Australian Taxation Office (ATO) PAYG requirements, we hereby reserve the right not to deal with entities unable to provide an ABN due to the administrative burden associated with the ATO's withholding requirements.

Not for Profit: Please indicate if your organisation is a not for profit.

GST: Please indicate if your organisation is registered for GST.

Postal Address: The organisation address to which all correspondence will be sent.

Contact Name and Position Held: We need to know the name of your organisation's office bearer who is making the application, and that person's position. The person whose name appears here must sign to accept responsibility for ensuring that the funds are used for the requested purpose, that the agreed recognition is obtained and that the feedback form and photographs depicting our investment are submitted to us within 6 weeks of completion of your project/activity.

Contact Information: We might need to talk to you, please provide an email address and telephone numbers of the person making the application.

Event/Project Description: What is happening that you need our support for?

Expected Completion Date: Please indicate the date of your event or the date you expect the project to be completed.

Cash Investment requested and use: Please indicate the amount of cash you are requesting and describe how it will be used. Note that once the application has been approved the funds must be used for the purpose indicated on the application. If the agreed project does not go ahead the funds must be returned to Community Bank Mundaring.

In-kind investment requested and why: Please indicate how we can help other than an investment of cash.

Other fundraising: Have you applied for sponsorship from any other organisation, and if so, who? Are you fundraising for the event and/or project yourselves?

Positive outcomes for your organisation: Describe the benefits your organisation will receive from the specified activity.

The information simply helps Community Bank Mundaring to make more efficient decisions on appropriate community investments.
