## 3. Gift Card Use

- 3.1. Gift card is valid for use at any participating retailer only (also referenced as a 'Gold Loving Retailer or Service Provider'). - 3.3. Each gift card may be used to purchase goods or services at one (1) participating retailer only. Gift card must be surrendered at the time of purchase in order to redeem. Any unused balance of a gift card will be forfeited.
