

- Your organisation must be an incorporated body, have DGR status or be a community non-for-profit organisation
- All outcomes for grants and sponsorship applications will be notified in writing
- We'll request you help promote your local Community Bank as part of your sponsorship within your network
- Activities arising from the sponsorship or grant must take place within our district and/or benefit residents and workers within our region

Key criteria that are <u>favourably</u> assessed in our program include:

- Applicant is contributing to the project or event themselves
- Projects that provide wider benefit to the community to a variety of people
- Partnership projects & initiatives (e.g. with Cardinia Shire, City of Casey or other community groups)
- Applicant has sought out other funding opportunities
- Applicant has a strong commitment to further engagement with the local branch
- Signage and promotion opportunities for the local branch
- Applications that align with supporting the social wellbeing and economic development of the community.

In 2024 we have two categories, being sponsorship and grants, the definition of these are:

Sponsorship: Under a sponsorship arrangement, the organisation seeking the sponsorship will provide value to the local branch in the form of advertising, signage, naming rights, event invitation and/or other type of benefit of value as outlined by the organisation. Sponsorship could be of an event, sporting season or yearlong agreement to support

Grants: Grants are funds provided to organisations to underwrite the costs of specific projects or programs. This project must be focused on social wellbeing and economic development of the community. Completion date is within 12 months of receiving funds.
