Criteria for the application of sponsorship and grant funding may change to reflect changing circumstances but initially the following criteria will apply:

Generally individual applications will not be supported.

The applicant is expected to be a customer of the Parkdale and Mentone East **Community Bank** [®] branches for its banking needs, unless it can be demonstrated that this bank cannot provide the specific services required. It is also preferred that organisations have a customer history at the Parkdale and Mentone East **Community Bank**[®] branches. Any support generated by your organisation will be taken into account when assessing future applications.

Applicants for sponsorship funding must demonstrate how the Parkdale and Mentone East **Community Bank**[®] branches financial support will benefit the community or a significant section of it, and/or be offering some reciprocal support such as:

- Additional banking business (also from members and friends)
- Signage external and internal
- Advertising (logo) in newsletter, website, stationary and annual reports
- Logo on sporting attire
- Media releases and presentation photos
- Opportunities for speaking engagements at presentation nights and other events. (photos of which may be used for publicity purposes, both within the Parkdale and Mentone East Community Bank[®] branches and in newsletters)

Parkdale and Mentone East **Community Bank**[®] application must be submitted using the following form, together with a letter on club letterhead if necessary, and include.

- A description of the project
- Level of sponsorship/grant funding sought
- Anticipated benefit to the community
- Evidence to support the financial viability of group seeking support

It may also become necessary for us to request additional information and clarification.

Successful applicants will be required to arrange a suitable opportunity, for Parkdale and Mentone East **Community Bank®** branches to make a presentation to your members, to explain how Community Banks differ from mainstream banks and how they can best support your application.
