# Our history.

Paynesville & District **Community Bank**<sup>®</sup> Branch opened its doors in December 2005 after a strong campaign by passionate community members eager to establish their own bank.

The idea for a **Community Bank**<sup>®</sup> branch arose in 2004 when Bendigo Bank encouraged the community to establish a branch. At the time, the district had been without a bank for almost 10 years. A steering committee of 17 people worked tirelessly to establish a **Community Bank**<sup>®</sup> branch, stimulating



local interest and raising capital to finance the project. When the prospectus launched in August 2005, Paynesville set a record for the largest amount ever collected at a launch.

The prospectus closed five weeks after it opened when the maximum total of \$800,000 was reached. The public company, Paynesville & District Financial Services Ltd, run by a volunteer Board, was formed to create a **Community Bank**<sup>®</sup> branch and to operate the franchise agreement between the company and Bendigo Bank. In December 2005 – just 13 months after the idea was raised – the Paynesville & District **Community Bank**<sup>®</sup> Branch proudly opened its doors on The Esplanade, Paynesville.

After an initial commencement stage of establishing the branch in the community where part of our capital was used for start up costs, franchise fees, building refurbishment and employment expenses, we are now at the stage where we are close to reaching the point of our original equity again, with our footings growing steadily over the last few years. This places our company in a good position for the future.
