# **How to complete this Proxy Form**

#### 1. Your name and address

This is your name and address as it appears on the Company's share register. If this information is incorrect, please mark the box and make the correction on the form. Please note, you cannot change ownership of your shares using this form.

### 2. Appointment of a proxy

A member entitled to attend and vote at the Meeting may appoint one proxy. A proxy need not be a member of the Company. A proxy may be an individual or a Company.

# 3. Identity of proxy

If you wish to appoint the Chairman of the Meeting as your proxy, mark the box. If you leave this section blank, the Chairman of the Meeting will act as your proxy.

## 4. Voting instructions
