Important news regarding dividends

The Board was delighted to announce in September 2009 a dividend payment for 2007-2008 & 2008-2009. One of the many challenges I faced was not being able to contact shareholders or having mail returned because it was not correctly addressed.

Keeping track of over 400 shareholders is not easy, so I would please ask you to check your details on the front of this envelope to ensure we have your correct details, if this is not correct either forward by mail to the branch or call into the branch and ask for a change of address form. I would take this opportunity to thank all our shareholders who have elected to provide their banking details of electronic acceptance of dividend payments.

It is a much quicker process usually within 48 hours to most accounts, and reduces our expenditure relating to the processing of dividend payments. Cheques, when issued, are not always quickly actioned with some going missing. I would encourage those of you that have not taken advantage of this electronic form of payment to forward your details to the branch.

I still have a small group of shareholders who have not provided their Tax File Numbers. Non supply of this number means when we issue payment for future dividends 48.5 percent is withheld and is retained by the Taxation Department.

I look forward to meeting you at our AGM to be held 6 November 2010.

Documentation in relation to this matter will be forwarded closer to the date.

Report from the Treasurer

It's been a year since I last wrote a report to shareholders. Despite the global economic downturn the financial strength of the Company has managed to hold its own.

However business growth has slowed from \$72 million of business on the books in my last report to about \$76.5 million now with over 3,300 accounts. On the bright side our business did grow in a time when many businesses went backwards.

Now that economic conditions have returned to normal we can expect further growth in the business.

We now have a new era in the business and a new Manager Roanna Brady. Roanna is a local coming from a well known sugar farming family background.

Since my last report the Company has paid its first dividends 5.5 cents for the year ended 30 June 2009

and 3.5cents for the year ended 30 June 2008 was paid at the same time.

The Company is on target to pay a dividend of 5.5 cents or greater for the current financial year.

The Company continues to invest into the community where funds and opportunities are available.

We are pleased to have entered into a major sponsorship with the Sarina Bowls Club. In the next financial year even greater funds will be invested into the Community.

I look forward to more community grants being given at our next Annual General Meeting in November 2010.

Just a little reminder on how the business operates. It is a franchise with Bendigo and Adelaide Bank Ltd and the gross income is shared equally between our local Company and Bendigo and Adelaide Bank Ltd.

We operate a branch for Bendigo and Adelaide Bank Ltd, which has the banking licence and has the normal risk associated with banking. We pay our local expenses e.g. rent, wages, electricity, computer hire etc. All the Directors are local volunteers.

So you can see from this that for any business you conduct one half of any fees, charges and costs you have to pay stays in the local community.

Remember the more business we have the greater the profitability and the more that can be returned to the community.
