## Portable Defibrillator Unit.

Just prior to Christmas, while shopping at LaManna supermarket, the worst thing happened. One of their shoppers suffered sudden cardiac arrest and collapsed in front of his family.

Fortunately for the patient, LaManna is one recipient of the 50 portable defibrillator units Strathmore **Community Bank®** Branch has donated to our community and the staff at LaManna have been professionally trained in the use of the unit.



What happens in the first few minutes following a sudden cardiac arrest (SCA) can make the difference between life and death. A victim's best chance of surviving is to receive a "shock" from a defibrillator. Defibrillation within the first few minutes of having SCA increases the chance of survival, to over 70%.

We are pleased to say that the patient was successfully "shocked", an ambulance arrived within minutes and the patient was rushed to hospital. He has since had lifesaving surgery and is now on the road to a full recovery. He made a special trip to our branch to express his thanks for our donation, he is grateful and told us the defibrillator unit definitely saved his life.


