Principal activity

The principal activity of the company during the financial half-year was facilitating Community Bank services under management rights of Bendigo and Adelaide Bank Limited (Bendigo Bank).

Review of operations

The profit for the company after providing for income tax amounted to \$143,411 (31 December 2024: \$187,171).

Significant changes in the state of affairs

There were no significant changes in the state of affairs of the company during the financial half-year.

Likely developments and expected results of operations

The Board's strategy includes pursuing further growth, and to this end, it is in the early stages of exploring opportunities with other community bank businesses. Further disclosure is omitted from the financial statements, as this may result in unreasonable prejudice to the company.

Matters subsequent to the end of the financial half-year

Subsequent to 31 December, the company became subject to a claim relating to matters arising after the end of the financial half-year. The matter is at an early stage and the outcome cannot be reliably determined at this time.

No adjustment has been made to the financial statements as the claim did not exist at the reporting date. The Directors are unable to estimate the potential financial impact, if any, at this time.

No other matter or circumstance has arisen since 31 December 2025 that has significantly affected, or may significantly affect the company's operations, the results of those operations, or the company's state of affairs in future financial years.

Note 1. Basis of preparation

These general purpose financial statements for the interim half-year reporting period ended 31 December 2025 have been prepared in accordance with Australian Accounting Standard AASB 134 *Interim Financial Reporting* and the *Corporations Act 2001*. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34 *Interim Financial Reporting*.

These general purpose financial statements do not include all the notes of the type normally included in annual financial statements. Accordingly, these financial statements are to be read in conjunction with the annual report for the year ended 30 June 2025 and any public announcements made by the company during the period.

The accounting policies adopted are consistent with those of the previous financial year and corresponding interim reporting period, unless otherwise stated.

Note 2. Economic dependency

The company has entered into a franchise agreement with Bendigo Bank that governs the management of the Community Bank. The company is economically dependent on the ongoing receipt of revenue under the franchise agreement. The franchise agreement expires in February 2028.

The directors have a reasonable expectation that a new franchise agreement will be signed prior to the expiry date.

Report on the half-year financial report
