Meet our new Chairman, Merv

It gives me immense pleasure to provide my inaugural Chairman's report for our October 2015 newsletter.

As some may already be aware, I am a relatively new Board member of Wantirna **Community Bank**[®] Branch company having been elected to the Board in December 2014.

However prior to my retiring from full time employment, I spent 47 years in the banking and finance industry, including 11 years as the Branch Manager at Pinewood **Community Bank**[®] Branch in Mount Waverley.

It was during the last 11 years of my employment as a **Community Bank**[®] Branch Manager that I gathered a thorough understanding of the **Community Bank**[®] model, which was the catalyst for me deciding to volunteer my time and energies to contribute as a **Community Bank**[®] company Director.

I have personally experienced the efforts required to get a **Community Bank**[®] branch opened, then the pressures experienced to reach profitability and finally, the immense benefits available to local community groups by partnering with the **Community Bank**[®] branch in our Community Investment Program. Another two applicants were unable to commit to full time Director roles but they have agreed to join the Board as committee members and their support is also welcomed.

During June - July 2015, three of our existing Directors resigned from the Board and we sincerely thank Geoff Purves, Cassandra Hatton and Robin Stenzel for their worthwhile contributions whilst members of the Board. Cassandra and Robin resigned due to increasing work commitments and Geoff, who has been a Director for over three years, has resigned to more fully enjoy his recent retirement.

In addition to the aforementioned Board changes, our longest serving Customer Service Officer, Debra Frazer, who commenced with the branch on our opening in September 2006, also decided to resign as at August 2015. Debra's contribution to the branch's development was formally acknowledged at a joint staff and board social event held in late August.

Our existing Customer Relationship Officer, Liz, has moved into Deb's role and we welcome Chris Wood to the team as Customer Relationship Officer.

The entire Wantirna **Community Bank**[®] Branch staff and Board members are focused on increasing our community engagement activities to assist further grow the branch, to bring the company into profitability.

Our Annual General Meeting is scheduled for Wednesday 25 November and further advices will follow to shareholders with full details. I am personally looking forward to meeting many of the supporters and shareholders of the branch, at the Annual General meeting.
