Explanatory Notes

This information has been included to assist you in making an informed decision about the resolutions proposed at the meeting.

Agenda item 3. Election of Directors

The following information is provided about candidates for election to the Board.

In accordance with the Company's constitution the nearest one third of Directors retire by rotation, creating 3 Board member vacancies. The Company did not receive any additional nominations from members for election as a director. Directors appointed by the Board during the year retire in accordance with clause 48 of the Company's constitution, and being eligible, have offered themselves for election to the Board. The directors retiring by rotation have offered themselves for re-election to the Board.

- a) **Edward Brian O'Shannessy**, retires by rotation in accordance with the constitution of the Company, and being eligible, offers himself for re-election.
- b) **Donna Kristine Scopelliti**, retires by rotation in accordance with the constitution of the Company, and being eligible, offers herself for re-election.
- c) **Glenn Stuart Thompson**, retires by rotation in accordance with the constitution of the Company, and being eligible, offers herself for re-election.

As the number of nominations received does not exceed the number of vacancies to be filled, no ballot is required and the persons so named, shall subject to member approval, be deemed to have been elected / re-elected as Directors.

The Chairperson of the Meeting intends to vote undirected proxies in favour of each item of business.

Appointment of Auditor

It is not necessary for subsequent AGM's to deal with auditor appointments as a regular item of business. Section 327B requires the auditor to be appointed by members at the AGM. The appointed auditor then holds office until they resign or are removed under the Corporations Act.
